# ACT

**To repeal the Provincial Development Council Act, 1996; and to provide for matters incidental thereto.**

**B**E IT ENACTED by the Provincial Parliament of the Western Cape, as follows:—

## Definitions

1. In this Act, unless the context indicates otherwise—

“**Provincial Development Council**” means the Provincial Development Council established by section 2(1) of the Provincial Development Council Act; and  
 “**Provincial Development Council Act**” means the Provincial Development Council Act, 1996 (Act 5 of 1996). 5

## Disestablishment of Provincial Development Council

2. The Provincial Development Council is disestablished. 10

## Repeal of Provincial Development Council Act

3. The Provincial Development Council Act and the Provincial Development Council Law Amendment Act, 2004 (Act 4 of 2004), are repealed.

## Transitional provisions

4. For the purposes of disestablishment of the Provincial Development Council— 15

(a) all movable assets and monies held by the Provincial Development Council as at its disestablishment are deemed to be held by the Department of the Premier; and  
 (b) all outstanding liabilities of the Provincial Development Council as at date of disestablishment must, subject to the Public Finance Management Act, 1999 (Act 1 of 1999), be settled by the Department of the Premier. 20

## Short title

5. This Act is called the Provincial Development Council Act Repeal Act, 2011.

## **Omskrywings**

1. In hierdie Wet, tensy dit uit die samehang anders blyk, beteken—  
**“Provinciale Ontwikkelingsraad”** die Provinciale Ontwikkelingsraad ingestel by artikel 2(1) van die Wet op die Provinciale Ontwikkelingsraad; en  
**“Wet op die Provinciale Ontwikkelingsraad”** die Wet op die Provinciale Ontwikkelingsraad, 1996 (Wet 5 van 1996).

## **Ontbinding van Provinciale Ontwikkelingsraad**

2. Die Provinciale Ontwikkelingsraad word onbind. 10

## **Herroeping van Wet op die Provinciale Ontwikkelingsraad**

3. Die Wet op die Provinciale Ontwikkelingsraad en die Wysigingswet op die Wet op die Provinciale Ontwikkelingsraad, 2004 (Wet 4 van 2004), word herroep.

## **Oorgangsbeplittings**

4. Met die oog op die ontbinding van die Provinciale Ontwikkelingsraad— 15
  - (a) word alle roerende bates en gelde wat die Provinciale Ontwikkelingsraad ten tye van ontbinding besit, geag in besit van die Departement van die Premier te wees; en
  - (b) moet alle uitstaande skulde van die Provinciale Ontwikkelingsraad op datum van ontbinding, behoudens die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), deur die Departement van die Premier vereffen word. 20

## **Kort titel**

5. Hierdie Wet heet die Wet op die Herroeping van die Wet op die Provinciale Ontwikkelingsraad, 2011.
