22. Ms N D Nkondlo to ask Ms B M Baartman, Minister of Finance:

- (1) (a) What rollover requests have been made to the National Treasury by (i) the Provincial Treasury and (ii) provincial departments and/or provincial entities in the 2025/26 financial year, (b) what are the details of the (i) rollover request amounts, (ii) **projects** for which rollovers have been requested, (iii) original budget per department or entity and (iv) reasons for the rollover requests, (c) whether an indication can be given of consultation with the relevant department, (d) what has been the response from the National Treasury about the requests and (e) what is the status of each request;
- (2) whether a list of rollover funds from the 2024/25 financial year can be made available; if so;
- (3) whether the funds had been spent to date; if not, why not;
- (4) in the light of the upcoming budget adjustments, whether her Department received requests for rollover of funds from the Provincial Treasury and other provincial departments and entities; if so, what are the relevant details?

Response:

(1)(a) The rollover requests and subsequent approval by National Treasury (NT) is detailed below. On 17 June 2025, NT preliminary approved R828.2 million of the total R829.2 million, unspent conditional grants.

Flood damage allocations and rollover:

Allocations to the Western Cape Province for the disasters that occurred between December 2023 and July 2024 and appropriated through various conditional grant allocations in the Adjustments Estimate of Provincial Revenue and Expenditure 2024, is as follows:

• Provincial Roads Maintenance Grant for infrastructure reconstruction and rehabilitation – R388m allocated to Vote 10 Infrastructure. Rollover request approved R374.542 m.

- Provincial Roads Maintenance Grant for Environmental Affairs and Development Planning (CapeNature) infrastructure reconstruction and rehabilitation – R183m allocated to Vote 10 Infrastructure. Rollover request approved R183m.
- Comprehensive Agricultural Support Programme Grant for infrastructure reconstruction and rehabilitation R300m allocated to Vote 11 Agriculture. Rollover request approved R269.350m

The remainder of the funding has been allocated to Water User Associations, Irrigation Boards and Casidra SOC Ltd. as per the approved Business Plan.

Social Sector EPWP Incentive Grant for Provinces – Vote 7 Social Development

Application for roll-over of unspent 2024/25 conditional grant allocation (R150 thousand). The Poverty Reduction and Sustainable Livelihoods sub-programme, responsible for the implementation of the EPWP programme contracted a service provider to manage the EPWP programme. The service level agreements signed with the service provider stipulates a contract period of 05 June 2024 to 31 March 2025. The programme's commencement date was 05 June 2024 as reflected in the contracts, thus terminating on 31 March 2025. The funding allocation breakdown was calculated based on 11 payments for the period of 10 months. The Department made 10 payments by 31 March 2025. Based on the above, roll-over funds of R 150 000.00 was requested in

Programme 5 Research and Development, Sub-programme 5.3 Poverty Reduction and Sustainable Livelihoods for the Incentive Grant to settle the balance owed to the Service Provider.
