- (a) What is the impact of the current Air Traffic and Navigation Systems (ATNS) failures on tourism in the province, (b) what is the (i) estimated loss in tourism numbers and (ii) resulting economic cost and (c) what actions are being taken to resolve these issues?

Response:

15 (a) What is the impact of the current Air Traffic and Navigation Systems (ATNS) failures on tourism in the province

The Department and Wesgro do not have access to the data that would allow us to ascertain the loss in tourism numbers and the economic cost because of ATNS failures.

15 (b) what is the (i) estimated loss in tourism numbers and (ii) resulting economic cost and

The Cape Town Air Access catalytic project has access to data provided by Airports Company South Africa, which provides an overall view of two-way passenger movements through the domestic and international terminals at Cape Town International Airport, as well as the domestic terminal at George Airport. This data is included in the tables below.

The Department deduced that the greatest impact of ATNS challenges has been at the George Airport with numerous flight cancellations since the withdrawal of the flight instrument procedures on 19 July. This is however not reflected in the passenger data above, as George Airport achieved a 3% year-on-year growth rate for 2024, compared to 2023.

In addition, Cape Town International Airport has achieved strong growth, recording 22 months of consecutive growth at the international terminal, reaching a 10% growth rate for 2024, compared to 2023.

15 (c) what actions are being taken to resolve these issues?

According to a media release by the Department of Transport, the Minister of Transport, Ms Barbara Creecy, established a Committee of Aviation Experts on 12 December 2024 to investigate the root cause of problems that have affected the ATNS. This committee of experts includes Wesgro CEO, Wrenelle Stander, and will function for a period of

six months. A draft diagnostics report with recommendations was submitted to the Minister at the end of January 2025. Further information on interventions by the Department of Transport should be directed to that department. Feedback on this is provided at the air access steering committee engagements which occur quarterly.

- (c) watter stappe gedoen word om hierdie kwessies op te los?

Antwoord:

15 (a) Wat is die impak op toerisme in die provinsie van die onlangse probleme by die Lugverkeer-en-navigasiestelsels?

Die Departement en Wesgro het nie toegang tot die data wat ons sal toelaat om die verlies in toerismegetalle en die ekonomiese koste weens die ATNS se foute te bepaal nie.

15 (b) Wat is die (i) beraamde verlies in die getal toeriste en (ii) die gevolglike ekonomiese koste?

Die Cape Town Air Access katalitiese projek het toegang tot data wat deur die Lughawensmaatskappy van Suid-Afrika verskaf is, wat 'n geheelbeeld op tweerigting

passasiersbeweging deur die binnelandse en internasjonale terminale by Kaapstad Internasjonale Lughawe voorsien, sowel as dié van die binnelandse terminaal by die George Lughawe. Hierdie data word in die volgende tabelle verskaf.

Die Departement het afgelei dat die grootste impak van die uitdagings by ATNS by die George Lughawe ondervind is, met talle vlugkansellasies sedert die vluginstrumentprosedures op 19 Julie onttrek is. Dit word egter nie in die passasiersdata hier bo weerspieël nie, aangesien George Lughawe, in vergelyking met 2023, 'n jaarlikse groeikoers van 3% vir 2024 behaal het.

Daarby het Kaapstad Internasjonale Lughawe 'n sterk groeikoers behaal en 22 maande van opeenvolgende groei is by die internasjonale terminaal waargeneem, en in vergelyking met 2023 is 'n 10% groeikoers in 2024 behaal.

16 (c) Watter stappe word gedoen om hierdie kwessies op te los?

Luidens 'n persverklaring deur die Departement van Vervoer, het die Minister van Vervoer, me. Barbara Creecy, op 12 Desember 2024 'n Komitee van Lugvaartkenners aangestel om die kernoorsake te ondersoek van probleme wat die ATNS geaffekteer het. Hierdie komitee van kenners sluit Wesgro HUB Wrenelle Stander in en sal vir 'n tydperk van ses maande werksaam wees. 'n Konsep- diagnostiese verslag met aanbevelings is aan die einde van Januarie 2025 by die Minister ingedien. Verdere

inligting oor ingryppings deur die Departement van Vervoer moet van daardie departement aangevra word. Terugvoering hieroor word by die kwartaallikse vergaderings van die lugtoegangsbestuurskomitee voorsien.
