New questions:

4. Mr B N Herron to ask Dr I Meyer, Minister of Agriculture, Economic Development and Tourism:

Over the 2025 MTEF period, R43,789 billion has been allocated to the Growth for Jobs Strategy (G4J Strategy), which sets an ambitious annual economic growth target of 4% to 6%:

(a) What success, if any, has the G4J Strategy, adopted in 2023, achieved since being implemented, (b) what internal benchmarks or review mechanisms have been established to assess its effectiveness and to ensure that targets are met and (c) how is progress being measured beyond economic projections?

Response:

4 (a) The table below indicates the success of the G4J Strategy since being adopted in 2023, progress on implementation and the specific metrics used to measure results.

(b) and (c) Internal benchmarks or review mechanisms established to assess effectiveness and to ensure that targets are met and progress measurement beyond economic projections are detailed below.

The G4J system includes transversal indicators which allow relevant outputs and outcomes across the departments to be aggregated on an annual basis. At the time of response, the financial year has not been concluded for 2024/25 and the report for the current financial year will only be finalised towards the end of May 2025.

Important note: Not all outcome indicators can be calculated/tracked on an annual basis. The G4J IQ team are in the process of developing a macro-economic tracker which will be used to provide a regular dipstick of progress.

This has been done with the assistance of your provincial corporate IT division. All G4J projects are loaded onto the proposal system module and then reported on monthly via the reporting module.

(b) en (c) Interne maatstawwe of hersieningsmeganismes wat gevestig is om doeltreffendheid te assesseer en om te verseker dat teikens bereik word, asook die meting van vordering buite ekonomiese vooruitskatting, word hieronder uiteengesit.

Die G4J-stelsel sluit transversale aanwysers in. Die uitkomste word op 'n jaarlikse basis saamgevoeg. Ten tyde van dié antwoord is die 2024/25-boekjaar nog nie afgehandel nie en die verslag van die huidige boekjaar sal eers aan die einde van Mei 2025 gefinaliseer word.

Die transversale uitkomste vir 2023/24 lyk as volg:

- 1 684 besighede is ondersteun.
- 14 ingrypings is ondersteun vir verbeterde gemak van sake doen.
- 28 348 burgers is met minstens een ekonomiese geleentheidsroete ondersteun.
- 15 304 poste is geskep of volgehou.

Neem asseblief kennis: Nie alle uitkomste-aanwysers kan op 'n jaarbasis uitgewerk/nagespoor word nie. Die G4J se IK-span ontwikkel tans 'n makro-ekonomiese naspoorder wat as 'n gereelde meetstok van vordering gebruik sal word.

- Vyf nuwe vlugroetes is gevestig.

- Bystand aan 1 525 besighede.

Hoogtepunte van PFA 3: Energieveerkragtigheid en Oorgang na Netto Nul Koolstof 2023/24-afsluitingsverslae

- Verminderde afhanklikheid van Eskom deur die byvoeging van 743 MW kapasiteit in 2023/24.
- Bekendstelling van verspreidingsgereedskapstel (*wheeling toolkit*), wat gebruik word as 'n basis vir die ontwikkeling van 'n nasionale gereedskapstel.
- Energieveerkragtigheidsingrypings is in 30 munisipaliteite gedoen en 290 besighede is ondersteun.
- Begin van die Municipale Onafhanklike Kragprodusent-verkrygingsprojek (MIPPP), die eerste van sy soort in Suid-Afrika.

Hoogtepunte van PFA 4: Waterveerkragtigheid 2023/24-afsluitingsverslae

Hoogtepunte van PFA 6: Infrastruktuur en 'n Gekonnekteerde Ekonomie 2023/24-afsluitingsverslae

- Die Leeuloop & Stigterstuin/Kunstekaap-lewensvatbaarheidstudie is afgehandel, en die konsultasieproses oor die Stigterstuin/Kunstekaap Wet op die Bestuur van die Onroerende Regeringsbates (GIAMA) is voltooi.
- 74 e-Sentrums word bestuur en 186 geakkrediteerde opleidingsgeleenthede is geregistreer, en 'n mobiele e-Sentrum is bekendgestel.
- 650 werksgeleenthede is geskep.
- 'n Toets- reiskoepon vir werksoekers is op 9 Februarie 2024 bekendgestel.
- Een geval van verbetering van gemak van sake doen deur ingryping met die Voorkeurverkrygingsbeleid.

Hoogtepunte van PFA 7: Verbeterde Toegang tot Ekonomiese Geleenthede en Indiensneembaarheid 2023/24-afsluitingsverslae

- 3 332 mense kon toegang tot indiensneembaarheid en ekonomiese roetes verkry (uitgesluit DKES, aangesien hulle tans 'n studie doen om syfers vas te stel).
- Direkte befondsing van R30 miljoen en indirekte befondsing van R15 miljoen wat vir PFA-ingrypings benut is.
- 3 020 jeuggeleenthede is geskep, en 33 000 begunstigdes wat deur die jeug ondersteun word (DKES).
- 44 skole is betrokke in die toets- beroepsprojek.

Meganismes is in plek om te verseker dat departemente terugvoering gee oor hul bydraes tot die bereiking van die G4J Strategie se doelwitte. DEOT het 'n stelsel vir G4J projekverslagdoening ontwikkel, sowel as 'n verslagdoeningskontroleskerm om

nasporing op 'n individuele projekvlak te visualiseer en wat op die vlakke van prioriteitsfokusareas en departemente saamgevoeg word. Dit is gedoen met die bystand van jou provinsiale korporatiewe IT-afdeling. Alle G4J-projekte word op die stelselmodule vir voorstelle gelaai en terugvoering geskied maandeliks deur die verslagdoeningsmodule.
