(a) What is the detailed breakdown per (i) subprogramme and (ii) conditional grant as at end of (aa) September 2024 and (bb) March 2025, (b) (i) what were the Minister and Members of Executive Council (MINMEC) priorities, (ii) what were the targets for the year and (iii) how did the province align its (aa) plans and (bb) expenditure with these priorities and targets, (c) what (i) is the number and (ii) are the details of projects that contributed to 40% of the budget being set aside as a priority, (d) what was the allocated budget for (i) land acquisition and (ii) re-blocking in his Department's original business plan and (e) what was his Department's expenditure breakdown at the end of (i) September 2024 and (ii) March 2025?

(b) (i) The key priorities outlined by the Minister of Human Settlements for the 2024/25 financial year are closely aligned with the MINMEC priorities and the grant frameworks that guide funding allocations across provinces and municipalities. The following ministerial priorities are directly supported through the Human Settlements grant framework:

# Upgrading of Informal Settlements

Funded through the Informal Settlements Upgrading Partnership Grant (ISUPG) and the Urban Settlements Development Grant (USDG), this priority supports in-situ upgrading, basic services, re-blocking, and relocations from high-risk areas.

## Affordable and Social Housing Delivery

This priority is funded through the Human Settlements Development Grant (HSDG) and the Consolidated Capital Grant (CCG). It focuses on broadening access to housing opportunities, including support for households that fall outside the fully subsidised income bracket (commonly referred to as the "missing middle") through First Home Finance. It also enables the development of rental housing and higher-density residential projects, particularly in well-located areas.

#### Title Deeds and Tenure Security

The HSDG funds initiatives aimed at issuing outstanding title deeds to qualifying beneficiaries and enhancing security of tenure for low-income households.

Eradication of Unsafe Structures (including Mud Houses and Asbestos Roofs)

This includes the removal of asbestos roofing and other hazardous building materials, as well as mud houses particularly in rural areas. This is addressed via the ISUPG and Emergency Housing Fund, with a focus on replacing structurally unsafe housing, particularly in rural areas.

Catalytic Projects in Priority Development Areas (PDAs)

The USDG supports catalytic human settlements development in well-located urban areas, aligned to spatial transformation and integrated development principles.

Land Acquisition for Integrated Human Settlements

The HSDG enables provinces to acquire well-located land for future housing developments, in line with spatial justice goals.
