#### 1. Opening and welcome

The Chairperson opened the meeting and welcomed everyone present.

# 2. Apology received

The Chairperson informed the Committee that Member Brinkhuis, G from AL JAMA-AH has tendered an apology for the rest of the week, he will not be attending the interviews, however, Member Makamba-Botya, from the EFF, is an alternate Member and will be attending the interviews. #### 3. Feedback on candidates
