## **3. Consideration and adoption of draft Minutes of meetings held on 26 November 2014 and 03 February 2015**

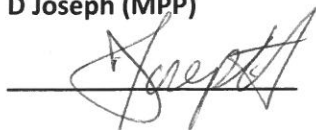
The Chairperson tabled the draft minutes that where considered and adopted.
