- 5. Discussion on recommendations for international study tour.

The Committee **RESOLVED** to request the WCPP research section to undertake the following research in preparation for the submission of a proposal to undertake an international study tour during the 2015/2016 financial year:

- 5.1. A visit to Toronto in Canada that focuses on the capacitation (including support measures for financial devolution) of the local government sphere in the three tier system and the role that regional governments play in this regards.
- 5.2. A visit to the World Economic Forum in America/ Switzerland that focuses on how countries have responded to the global economic recession.
- 5.3. A visit to the Nevada University in America that focuses on the University's Gambling Management Programme.
