- 3.2.2 Progress report on the status of the municipalities that did not submit their Title Deeds Business Plans:
- 3.2.3 List of all municipalities included on the Title Deed Restoration Programme;
- 3.2.4 List of Internal bursaries that were allocated to beneficiaries, the allocation criteria and the geographical location; and
- 3.2.5 The business plans for the Department's four priority areas that were visited by the Minister in the different municipalities.
