3.2.1 Status report on the 120 informal settlements that were identified for upgrading in the Medium Term Budget. The Department is requested to provide the project commencement dates and geographical location of each project;

3.2.2 Progress report on the status of the municipalities that did not submit their Title Deeds Business Plans;

3.2.3 List of all municipalities included on the Title Deed Restoration Programme;

3.2.4 List of Internal bursaries that were allocated to beneficiaries, the allocation criteria and the geographical location; and

3.2.5 The business plans for the Department's four priority areas that were visited by the Minister in the different municipalities.
