- 3.2 The Committee RECOMMENDED that:

When Provincial Treasury engage the Fiscal and Financial Commission (FFC) on policy issues, they highlight the matter with regard to the Municipal Infrastructure Grant and the Equitable Share to reduce the financial strain on rural municipalities.
