1. Opening and Welcome

The Chairperson opened the meeting and welcomed the members of the Committee and the Departmental officials.

2. Briefing by the Department of Transport and Public Works on the challenges with aligning the Department's sector plans with municipal IDP's, and SDF's

The Department proceeded with a briefing on the challenges with aligning the Department's sector plans with municipal IDP's, and SDF's.

Ms J Gooch, Head of Department highlighted that IDPs generally lack a long-term development trajectory and current intergovernmental planning structures does not address the misalignment timeously. Provincial Departments essentially operate in 'isolation' from one another and take a sectoral approach to planning and delivery of infrastructure. There is a need for a systematic process which results in a long term $(5-10~{\rm year})$ integrated provincial infrastructure pipeline to be developed where longer-term infrastructure projects, as derived from the U-AMPs and C-AMPS, can be tabled for discussion.

3. Briefing on the Provincial Property Committee's Annual Report for 2018 and the Premier's Annual Report for 2018 relating to provincial state land.
