ACT

To appropriate an additional adjusted amount of money from the Provincial Revenue Fund in respect of funds that have become available for the requirement of the Province of the Western Cape in respect of the 2019/20 financial year; and to provide for matters incidental thereto.

WHEREAS the National Treasury has allocated additional funds to the Province in respect of the national conditional grant: Human Settlements Development;

AND WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustment budget in the Provincial Parliament in respect of funds that have become available;

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province,

BE IT THEREFORE ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2019 (Act 4 of 2019), has the meaning assigned to it in that Act. 5

Appropriation of adjusted amount of money for requirement of Province

2. (1) An adjusted appropriation by the Provincial Parliament of money from the Provincial Revenue Fund for the requirement of the Province in the 2019/20 financial year, to a vote and main division within a vote, and for the specific listed purpose, is set out in the Schedule. 10

(2) The spending of the appropriation contemplated in subsection (1) is subject to the Public Finance Management Act.

Amount listed as specifically and exclusively appropriated

3. The amount listed in the Schedule as specifically and exclusively appropriated and that refers to national conditional grants, may be used only for the purpose stipulated in the Division of Revenue Act and in accordance with the framework published in terms of that Act. 15

Short title

4. This Act is called the Western Cape Additional Adjustment Appropriation Act 20 (2019/20 Financial Year), 2020. 20

Uitleg

1. In hierdie Wet, tensy dit uit die samehang anders blyk, het enige woord of uitdrukking waaraan 'n betekenis geheg is in die Wes-Kaapse Begrotingswet, 2019 5 (Wet 4 van 2019), die betekenis daarvan geheg in daardie Wet.

Bewilliging van aangesuiwerde bedrag geld vir behoefté van Provincie

2. (1) 'n Aangesuiwerde bewilliging deur die Provinciale Parlement van geld uit die Provinciale Inkomstefonds vir die behoefté van die Provincie in die 2019/20- finansiële jaar, vir 'n begrotingspos en hoofindeling binne 'n begrotingspos, en vir die spesifieke 10 doeleinde gelys, word in die Bylae uiteengesit.

(2) Die besteding van die bewilliging beoog in subartikel (1) is onderhewig aan die Wet op Openbare Finansiële Bestuur.

Bedrag gelys as spesiek en uitsluitlik bewillig

3. Die bedrag in die Bylae gelys as spesiek en uitsluitlik bewillig en wat verwys na 15 nasionale voorwaardelike toekenning, mag slegs vir die doel bepaal in die Division of Revenue Act en ooreenkomsdig die raamwerk gepubliseer ingevolge daardie Wet gebruik word.
