BILL

To shift certain earmarked funds to a different economic classification within a vote for a new purpose; to shift certain earmarked funds to a different economic classification and programme within a vote; to appropriate an additional adjusted amount of money from the Provincial Revenue Fund in respect of funds that have become available for the requirements of the Province of the Western Cape in respect of the 2017/18 financial year; and to provide for matters incidental thereto.

WHEREAS the Province is experiencing ongoing severe drought and water crises;

AND WHEREAS the Western Cape Government acknowledges the need to increase water security at certain municipalities;

AND WHEREAS the Western Cape Government is required to shift funds within a vote to assist certain municipalities in achieving this objective;

AND WHEREAS the National Treasury has allocated additional funds to the Province in respect of the national conditional grant: Human Settlements Development Grant;

AND WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustments budget in the Provincial Parliament to provide for the shifting of funds within votes and in respect of funds that have become available;

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province,

B E IT THEREFORE ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2017 (Act 1 of 2017), has the meaning assigned to it in that Act. 5

Appropriation of adjusted amounts of money for requirements of Province

2. (1) Adjusted appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2017/18 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedule. 10

(2) The spending of the appropriations contemplated in subsection (1) is subject to the Public Finance Management Act.

Amounts listed as specifically and exclusively appropriated

3. Amounts listed in the Schedule as specifically and exclusively appropriated and that refer to—

- (a) national conditional grants, may be used only for the purpose stipulated in the Division of Revenue Act and in accordance with the framework published in terms of that Act; and 5
- (b) earmarked allocations, may be used only for the purpose stipulated in the Schedule and in accordance with the directives issued from time to time in terms of section 4 of the Western Cape Appropriation Act, 2017.

**MEMORANDUM ON THE OBJECTS OF THE
WESTERN CAPE ADDITIONAL ADJUSTMENTS
APPROPRIATION BILL (2017/18 FINANCIAL YEAR), 2018**

The Bill provides for the appropriation of an additional adjusted amount of money in the 2017/18 financial year that has become available for the requirements of the Province of the Western Cape, Department of Human Settlements, in respect of the national conditional grant: Human Settlements Development Grant. The amount is specifically and exclusively appropriated and may be used only for the purpose as stipulated in the Division of Revenue Act, 2017 (Act 3 of 2017), and in accordance with the framework published in terms of that Act.

The Bill also provides for the shifting of certain earmarked funds to a different economic classification within a vote for a new purpose and the shifting of certain earmarked funds to a different economic classification and programme within a vote to make funds available to certain municipalities in order to assist those municipalities to increase water security. The amounts are specifically and exclusively appropriated as transfers and subsidies under the relevant vote and may be used only for the purpose stipulated in the Schedule and in accordance with the directives issued from time to time in terms of the Western Cape Appropriation Act, 2017.

WETSONTWERP

Om sekere geormerkte fondse na 'n ander ekonomiese klassifikasie binne 'n begrotingspos vir 'n nuwe doel te verskuif; om sekere geormerkte fondse na 'n ander ekonomiese klassifikasie en program binne 'n begrotingspos te verskuif; tot bewilliging van 'n bykomende aangesuiwerde bedrag geld uit die Provinsiale Inkomstefonds ten opsigte van fondse wat beskikbaar geword het vir die behoeftes van die Provinsie Wes-Kaap ten opsigte van die 2017/18-boekjaar; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

AANGESIEN die Provinsie onder 'n voortdurende erge droogte en waterkrisisse gebuk gaan;

EN AANGESIEN die Wes-Kaapse Regering erken dat dit nodig is om watersekerheid by sekere munisipaliteite te verhoog;

EN AANGESIEN dit van die Wes-Kaapse Regering vereis word om fondse binne 'n begrotingspos te verskuif om sekere munisipaliteite by te staan in die bereiking van hierdie doelwit;

EN AANGESIEN die Nasionale Tesourie bykomende fondse ten opsigte van die nasionale voorwaardelike toekenning: Toekenning vir die Ontwikkeling van Menslike Nedersettings aan die Provinsie toegewys het;

EN AANGESIEN artikel 31 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), bepaal dat die Provinsiale Minister verantwoordelik vir finansies 'n aansuiweringsbegroting in die Provinsiale Parlement ter tafel kan lê om voorsiening te maak vir die verskuiwing van fondse binne begrotingsposte en ten opsigte van fondse wat beskikbaar geword het;

Uitleg

Bewilliging van aangesuiwerde bedrae geld vir behoeftes van Provinsie

2. (1) Aangesuiwerde bewilligings deur die Provinsiale Parlement van geld uit die Provinsiale Inkomstefonds vir die behoeftes van die Provinsie in die 2017/18-boekjaar, vir begrotingsposte en hoofdelings binne 'n begrotingspos, en vir die spesifieke doeleindes gelys, word in die Bylae uiteengesit. 10

(2) Die besteding van die bewilligings beoog in subartikel (1) is onderhewig aan die Wet op Openbare Finansiële Bestuur.
