 - (2) (a) what is the total amount of money that was spent on road-safety awareness campaigns in the 2016/17 financial year and (b) what is the total amount of money that has been allocated to road-safety awareness campaigns for the 2017/18 financial year;
 - (3) (a) what is the total amount of money that was spent on road-safety awareness campaigns during Easter in the 2016/17 financial year and (b) what is the total amount of money that has been allocated to road-safety awareness campaigns for Easter in the 2017/18 financial year?

- (a) What are the details of the water collection points to be rolled out in the event of Day Zero, (b) how will the government ensure the collection and delivery of water from collection points for residents who are unable to carry it, such as the elderly, the disabled or the infirm, (c) at what time will water collection points open and close, (d) how will residents collecting water for their family members prove that they are collecting water for numerous individuals in their households, (e) how will water collection points be protected and monitored during collection times, (f) how will information from water collection points be communicated to the residents using them and (g) with which private-sector partners will her Department be working to mitigate water wastage and provide Western Cape residents with an additional supply of water?

(3) in the event of Day Zero, whether certain medical procedures will be prioritised; if so, have these procedures been identified;

(4) how are health facilities across the province communicating their various water-saving measures to patients and their families?

(2) in the event of Day Zero, how will his Department assist the elderly, the disabled, the children at ECD centres and anyone who might not be able to access water at the proposed water points themselves;
