**1. Ms M M Wenger to ask Mr D Plato, Minister of Community Safety:**

Whether there have been any (a) police officials, (b) specialised units or (c) flying-squad cars and/or (d) personnel stationed at the Milnerton home of a certain person whose name has been furnished to his Department for the purpose of this reply; if so, for each instance, (i) what are the reasons therefor, (ii) how many police personnel have been stationed at this address from 1 May 2017 to date, (iii) from which units and stations have these officials been drawn and (iv) for how long will officials and/or vehicles be placed at this home?

**2. Ms M M Wenger to ask Mr D Plato, Minister of Community Safety:**

With reference to the incident of police brutality involving a Nigerian man who was assaulted in Riebeeck Street, Cape Town, in March 2014:

- (1) What disciplinary action, if any, was taken against the South African Police Service officers involved;
- (2) whether the Independent Police Investigative Directorate (IPID) investigated the matter; if not, why not; if so, (a) who did the IPID investigate and (b) what were the outcomes of the investigation;
- (3) whether any recommendations of the IPID investigation were followed; if not, why not; if so, what are the relevant details?

**3. Mr P Uys to ask Mr A T Fritz, Minister of Social Development:**

Whether his Department uses any non-governmental organisations (NGOs) for a theatre production to educate the community about the dangers of social evils like drug abuse, domestic violence, theft and human trafficking; if not, why not; if so, (a) which NGOs were used in the last three years and (b) who do the NGOs approach in his Department to render such a service?

(1) What is the situation regarding the Chief Financial Officer of the Mossel Bay Municipality, whose name has been furnished to his Department for the purpose of this reply, after he had recently been found guilty of fraud, corruption and transgression of the Public Finance Management Act;

(2) whether the person is still employed by the Mossel Bay Municipality; if so, (a) why and (b) what will he be doing to address the situation?
