1. Mr F C Christians to ask Mr I M Sileku, Minister of Mobility:

Whether he has received feedback from Sanral as to when the central rail line will be fully functional; if so, what are the relevant details?

2. Mr F C Christians to ask Mr T A Simmers, Minister of Infrastructure:

With reference to the article "The construction mafia in Cape Town is disrupting building construction and halting construction projects" by Lindsey Shutters published on 18 June 2024 in *Bizcommunity*:

- (1) (a) What is the value of the building projects currently being halted by the construction mafia's extortion and (b) what are the details of these projects;
- (2) whether any lives have been lost during intimidation attempts by the mafia; if so, what are the relevant details?

3. Mr D G Jacobs to ask Mr D J Maynier, Minister of Education:

(a) How many schools in historically coloured areas will be affected by this envisaged teacher cuts in 2025 and (b) how many (i) schools are planned to be built in the currently financial year and (ii) of these schools will be built (aa) on the Cape Flats and (bb) in historically coloured areas?

4. Mr M K Sayed to ask Mr A R Winde, Premier:

Regarding the allegations of sexual misconduct involving senior managers in the provincial government:

- (1) Whether he is aware of sexual harassment complaints that have been lodged against a certain person, whose name has been furnished to his Department for purpose of his reply, as far back as 2016; if so, what are the relevant details;
- (2) what is the total number of sexual misconduct allegations reported against this person;
- (3) whether a copy of the investigation report can be made available or be shared with the Members of the Standing Committee on the Premier and Constitutional Development and the Standing Committee on Local Government, Environmental Affairs and Development Planning; if not, why not; if so, what are the relevant details;
- (4) what is the total expenditure by the provincial government for the independent investigation conducted by Advocate Jenny Williams into the allegations against this person;
- (5) what are the reasons for not releasing a copy of Adv Jenny Williams's report to the main complainant;
- (6) how many (a) ex-officials and (b) current officials of the Department of Local Government were interviewed by Adv Jenny Williams regarding the sexual harassment allegations against this person;
- (7) whether any affidavits have been submitted to the relevant authorities concerning this person's alleged sexual misconduct and mistreatment of female employees in the Department; if so, what are the relevant details;
- (8) what are the reasons for not suspending this person from his position while the investigation is ongoing;
- (9) what are the reasons why he has allowed this person to appeal against the report from Adv Jenny Williams?

- (2) what (a) criteria were used to identify the schools that will be affected by the reduced basket of teacher posts, (b) is the expected impact of the reduction in teaching posts on (i) schools and (ii) learners, (c) are the detailed information on the (i) number of schools, (ii) names of schools that will be affected by this reduction and (iii) number of learners at each affected school who will experience a reduction in teaching resources and (d) additional consequences are anticipated for the affected schools and their learners?

(2) (a) what measures are being taken by his Department to mitigate the impact of these reductions on (i) learners and (ii) teachers and (b) how will his Department support schools that must manage the transition and maintain educational standards despite the reduced number of teaching posts?

- (1) What is the (a)(i) current status of and (ii) progress that has been made with the establishment of the Violence Prevention Unit in her Department, (b) detailed breakdown of the expenditures associated with the Violence Prevention Unit since its inception to date and (c) detailed breakdown of all costs related to its (i) setup, (ii) operations and (iii) other relevant financial outlays;
- (2) what (a) are the most recent details concerning the recruitment and staffing of the Violence Prevention Unit, including (i) the existing vacancies and (ii)(aa) the number of staff members appointed and (bb) their roles and (iii) any ongoing recruitment efforts, (b) specific (i) tasks and (ii) milestones related to the unit's mandate have been accomplished since its inception and (c) is the impact of these achievements on the unit's objectives?

- (3) (a) how much has this Department spent on litigation related to this dispute, (b) what were the outcomes of the court case, (c) what is the current status of the out-of-court settlement and (d)(i) what are the reasons for the delays in registering an adjudicator and (ii) how are these delays being addressed?

- (3) whether the allegations of the Municipality's Municipal Public Accounts Committee (MPAC) have been brought to his attention; if not, why not; if so, what (a) are the relevant details and (b) is the status of the current oversight investigations into these allegations?

What is the (a) detailed breakdown of each of the 17 community-reported serious crimes for each police station in the province, (b) detailed breakdown of each of the contact crimes per police station in the province, including by (i) age, (ii) race and (iii) gender of the victims, and (c) total number of (i) women and (ii) children who were murdered in the province during this reporting period, including a breakdown by (iii) age, (iv) race and (v) gender?

- (1) How will he and his Department address the construction of a clinic on the NY14 sports grounds in Gugulethu;
- (2) whether he and his Department will allow the construction of a clinic on the NY14 sports grounds in Gugulethu to proceed; if not, why not; if so, (a) what are the relevant details and (b) how will he and his Department ensure that the sports grounds are preserved as part of Gugulethu's heritage;

- (3) what is the (a) total amount of funding transferred to the Municipality from the (i) provincial and (ii) national government for housing delivery from 2019 to 2024 and (b) detailed breakdown of the expenditure of these transfers?

- (1) (a) Why are Mitchells Plain learners being denied access to Grade 8 at schools in Mitchells Plain and, in particular, at the (i) Portland High School, (ii) Spine Road High School, (iii) Rocklands High School, (iv) High Cedar High School, (v) Lentegeur High School, (vi) Summerdale High School and (vii) Aloe High School and (b) where does his Department propose that these learners complete their secondary schooling;
- (2) (a) what are the details of the shortfall of capacity for secondary school learners in the Mitchells Plain area, (b) how much of the shortfall is related to school infrastructure, (c) how much of the shortfall is related to teacher shortages and (d) how many additional teacher posts will be lost in 2025 in Mitchells Plain;
- (3) (a) how does his Department plan to address the inability of learners from Mitchells Plain to access placement at a secondary school in Mitchells Plain and (b) what are the details of the plans and approved budgets that his Department have in place to build additional schools or expand existing schools in Mitchells Plain?

25. Mr B N Herron to ask Mr D J Maynier, Minister of Education:

With regard to the Western Cape Government's Social Infrastructure Accessibility Study (June 2017) for the Greater Saldanha Regional Spatial Implementation Framework that identified that there was, at that time, an undersupply of facilities, in particular "3 x secondary schools" for St Helena Bay:

- (1) Whether his Department addressed the undersupply of secondary school facilities in St Helena Bay; if not, why not; if so, what are the relevant details;
- (2) (a) what plans and budgets are in place for the development of secondary schools in St Helena Bay, (b) when will a new secondary school be built in St Helena Bay, (c) what has been the delay in addressing the undersupply of secondary schools identified seven years ago in the aforementioned study and (d)(i) how many secondary school learners are being transported to schools in Vredenburg and (ii) what is the annual cost of that learner transport;
- (3) the aforementioned study identified an undersupply of "five secondary schools" in Vredenburg, (a) how many secondary schools have been built in Vredenburg since that undersupply was identified in that study and (b) what are the details of those schools;
- (4) seeing that the Department has developed fewer than five secondary schools in Vredenburg and none in St Helena Bay, how has his Department planned for secondary school learners from St Helena Bay to have access to basic education;
- (5) how many learners (a) in Vredenburg and St Helena Bay can be accommodated in secondary schools in Vredenburg and (b)(i) will not gain access to a secondary school in Vredenburg in 2025 and (ii) what is his Department's plan for their education?
